Dear Academy Parents and Students,

I would like to welcome both new and returning students to Shannon Carney Dance Academy, and thank you for giving the Academy the opportunity to work with your children. Please keep the following information and policies to refer to throughout the year, and if there are any questions or concerns please feel free to call the office at any time.

### **SAFETY**

Our first priority at the Academy is safety. Parents must drop-off and pick-up students in the waiting area. Students are not permitted to leave the Academy without an adult. Please notify your teacher in writing if someone other than a parent will be picking up your child. Please be prompt when picking up children. If you are late we will keep student in the "blue room" with a teacher.

Parents must also notify your teacher and office in writing of any health concerns, including any food allergies and asthma.

# **PARKING**

Parking for SCDA is behind Bergey's and the Academy. Please refrain from parking directly behind Bergey's garages during their hours of operation. Please keep a lane open for the houses in the back. Please go slowly when pulling in and out of the lot.

# ATTIRE

Students must attend class in proper dance attire. Students are not permitted to wear jewelry or chew gum in the dance studio, for safety reasons. Hair should be secured away from the face, buns and French braids are recommended. A neat appearance will reflect in your dancing.

#### **BEHAVIOR**

Students must be respectful of teachers and students. Students who repeatedly disrupt class, are disrespectful, and/or break Academy policies may be dismissed from the Academy without a refund of tuition. Parents must also be respectful of teachers, students, and fellow parents. Failure of Parents to abide by studio policies may result in dismissal of student(s) form the Academy without a refund of tuition.

# CLASS CANCELLATION/SNOW POLICY

Missed classes due to cancellation, holidays, inclement weather, or illness can be made-up in an appropriate make-up class. There will be no refunds given; students should attend a make-up class. Check the Facebook Page and Email for notification of cancelled classes due to inclement weather.

#### **Email Blasts and Information**

The Academy gives frequent emails to keep parents/students informed throughout the year. This is our main form of communication. Copies are always posted throughout the studio. Please notify the office if you are not receiving our email blasts.

#### **Recital**

The Academy will have an end of the year Recital. Participation in the Recital is encouraged, but not mandatory. Costume purchases will be required for students participating in the recital. Tickets will also need to be purchased for anyone wishing to view the Recital. Costume fees are non-refundable. Dates, location, and other particulars about the Recital will be given by November.

#### **CLASS OBSERVATION**

The Academy has provided CCTV for your viewing pleasure. Please speak positively and in a kind manner about what you observe in class. Dance is an ongoing process and takes much time and effort to master technique and steps. Everyone learns at an individual pace. Please no comparisons of classes or students.

#### **TUITION POLICIES**

Tuition and fees are non-refundable. Tuition is based on an annual fee, not on number of classes per month. Tuition can be paid in one payment, 3 payments or 10 payments for your convenience. The 10-payment option is due the first week of each month, September-June. A late fee of \$5.00 will be assessed to accounts that are not paid by the 7<sup>th</sup> of each month. The 3 Payment option is due September 1<sup>st</sup>, December 1<sup>st</sup>, and March 1<sup>st</sup>. A late fee of \$5.00 will be assessed to accounts not paid by the 7<sup>th</sup> of each Payment Schedule. Tuition must be paid in full before Recital tickets can be purchased. A \$30.00 fee will be charged for any checks and/or returned Automatic Withdrawals returned due to insufficient funds.

#### WITHDRAWAL POLICY

Please notify the Academy in writing of withdrawal from class. A 30-day written notice is required.
